

NICCI Represents at India-Nepal Think Tank Summit 2025

New Delhi, India | April 2-5, 2025

The Vivekananda International Foundation (VIF), a prestigious and well-recognized Indian think tank based in New Delhi, hosted the *India-Nepal Think Tank Summit 2025* from April 2 to 5, 2025. This event brought together leading experts and stakeholders from both nations to explore avenues of cooperation and deepen mutual understanding.

On behalf of Nepal, the delegation was led by the Asian Institute of Diplomacy and International Affairs (AIDIA), a Kathmandu-based think tank. The Nepali team comprised representatives from the energy, trade, media sectors, and Chamber of Commerce representatives.





It was a privilege of participating in this Summit as a representative of the Nepal-India Chamber of Commerce & Industry (NICCI). The experience offered valuable insights into how bilateral dialogues are structured, with participation from high-level Indian government officials, former diplomats, scholars, academicians, sectoral experts, and private sector leaders.

The summit embodied what is known as *Track 1.5 diplomacy*, combining official and non-official actors to promote open, informed discussions on regional relations.

The Summit focused on strengthening bilateral cooperation between Nepal and India, particularly in the following sectors:

- Trade and investment
- Energy and power trade
- Tourism development
- Media collaboration
- Regional integration


Courtesy Call with H.E. Nepali Ambassador to India Dr. Shankar Prasad Sharma:

During the visit, the Nepali delegation paid a courtesy call to His Excellency Dr. Shankar Prasad Sharma, Ambassador of Nepal to India, at the Embassy Office on Barakhamba Road, New Delhi. We briefed the Ambassador on the outcomes of the Summit, which were overwhelmingly positive. The Indian counterparts expressed strong interest in continuing dialogue, especially in the areas of tourism, energy, and media cooperation.
